

Santa Fe Skating Club Membership Categories: 2011-2012 Membership Year

Adult: Available to any person between the ages of 18 and 55 (before December 1 of the current membership year). If you have tested within the USFS test structure and you are in this age group, this is the category for you. Includes a membership in US Figure Skating, a subscription to Skating Magazine and USFS Liability Insurance

Senior Adult: Available to any person over the age of 55 before December 1 of the current membership year. If you have tested within the USFS test structure and you are in this age group, you may join this category. Includes a membership in US Figure Skating and a subscription to Skating Magazine and USFS Liability Insurance.

Junior: Available to any person who is under the age of 18 before December 1 of the current membership year. If you have tested within the USFS test structure and you are in this age group, this is the category for you. Includes a membership in US Figure Skating, a subscription to Skating Magazine and USFS Liability Insurance

Collegiate: Available to any full time college student. This membership is good for a consecutive four-year period and the applicant can sign up any time in college. This membership option may only be used once. Includes a membership in US Figure Skating, a subscription to Skating Magazine and USFS Liability Insurance.

Additional skating family member: Available to any person of any age who is a linear member of the same family and at least one member of the family has qualified and joined the Santa Fe Skating Club as a full member. In order to qualify for this category, the initial family member must join at the highest level that he/she qualifies for. It does include a membership in US Figure Skating and the USFS Liability Insurance, but not a subscription to Skating Magazine.

Example: A family has an adult parent who has tested within the USFS test structure and two junior-age children who have tested. The parent must join the Club as an Adult Member, the children may join the Club as additional skating family members.

Second Club/Associate (non-home club member): Available to any person who is in good standing in any other skating club that is a member club of United States Figure Skating. Has all the privileges of a Santa Fe Skating Club member.

Recreational Skater: Available to any person who has **not tested** within the USFS test structure. If you have not tested within the USFS testing structure and previously have been a member of the Santa Fe Skating Club or any USFSA skating club, you may join this category. Includes a membership in US Figure Skating, a subscription to Skating Magazine and USFS Liability Insurance

Introductory Member: Available to any person who has **never** been a member of any USFS skating club. If you are a Basic Skills member you qualify for this level. By joining in June, you received 13 months this first year. Includes a membership in US Figure Skating, a subscription to Skating Magazine and USFS Liability Insurance

Please note that if you join SFSC as a Recreational Skater or an Introductory Member and begin USFS testing during the membership year, you must pay the difference between the Recreational fee or the Introductory Member fee and the Adult or Junior fee level (or additional skating family member level, if applicable) at least three (3) weeks before taking your test.

Coach: Available to a skating professional who coaches any member of the Santa Fe Skating Club. The coach needs to have completed the coach registration process with USFS before applying for membership. Includes a membership in US Figure Skating, a subscription to Skating Magazine and USFS Liability Insurance

Friend of the SFSC: Available to any person who wishes to support the Santa Fe Skating Club, but is **not a skater**.

BoardMember: Available to a non-skating parent who has never tested within the USFS test structure. The non-skating parent board member must have at least one child with a home club membership in Santa Fe Skating Club. Includes membership in US Figure Skating and the Liability Insurance.

All membership levels, with the exception of "Friend of the SFSC," are entitled to vote in all matters concerning the Santa Fe Skating Club, to skate in all Club sessions, shows, and exhibitions, and to take tests during Club sessions at fees established for Club members. The parent or guardian of any Club member who is under the age of 18 shall conduct all voting privileges on behalf of the minor child.
