Higher level skaters who wish to skate a longer program are welcome to discuss with show director
- COST:** THERE IS NO FEE TO SKATE IN THE GALA IN EXCHANGE FOR EACH SKATER OR GROUP OF SKATERS FURNISHING THEIR OWN CHOREOGRAPHY, MUSIC CUT AND COSTUME (PROBABLY WITH THE HELP OF THEIR OWN COACH). SKATERS WILL ALSO BE EXPECTED TO SELL A CERTAIN NUMBER OF TICKETS TO BE ANNOUNCED AT THE FIRST REHEARSAL.
- EVERYONE IN THE SHOW WILL BE EXPECTED TO SKATE IN THE OPENING AND FINALE NUMBERS WHICH WILL BE CHOREOGRAPHED BY MARTIN LEVY, SHOW DIRECTOR.**

Further, I agree to hold the Santa Fe Skating Club, all coaches who are involved in the Holiday Ice Show and the rehearsals for the Show, and all volunteers and agents of the Santa Fe Skating Club harmless from any and all liability, actions, causes of action, debts, claims or demands of any kind and release.

Additionally, by signing below the Skater or Parent/Legal Guardian understands, in the event that she/he cannot be reached, this form hereby gives permission to the physician selected by the Santa Fe Skating Club to hospitalize and secure proper treatment (including surgery) for the Skater. Moreover, by the Parent/Legal Guardian and Skater signing this form, they are agreeing to abide by all rules and reasonable authority of the Holidays on Ice Show's directors and volunteers, and that the Skater has been deemed physically able to participate in ice skating by a physician.
